MEMORANDUM

On the recommendations of the Selection Committee, the Competent Authority of this Directorate is pleased to offer the temporary & coterminous post of Sr. Research Fellow to Miss R. Ashwini D/o Sri R. Sambamurthy at the consolidated payment of Rs. 31,000/- for I & II year and Rs.35,000/- for III year + H.R.A. will be as per ICAR norms, under the DBT Project entitled "Development of transgenic chicken for production of human interferon alpha 2b: A therapeutic for treatment of viral diseases in human" on the following terms and conditions:-

- The Fellowship is purely temporary for the period upto 31/01/2021 or till the termination of the Project whichever is earlier.
- On appointment, she will draw the Fellowship at the consolidated payment of Rs.31,000/-for I & II year and Rs.35,000/- for III year. H.R.A. will be as per ICAR norms. She will not be entitled for any other allowances as admissible to the regular employees of the Council.
- The Fellowship shall take effect from the date the Fellow joins the Project.
- No residential accommodation and transportation will be provided.
- She will devote her whole time to the approved research programme/study under the Fellowship and will not be allowed to accept or hold another appointment paid or otherwise and will be under the administrative control of the Principal Investigator of the DBT Project.
- Her headquarters will be at Hyderabad for the present but she will be liable to serve in any of the ICAR Adhoc scheme.
- The Fellow will not be permitted to resign her Fellowship during the period of the currency except with the prior permission of the Competent Authority.
- If, at any time in the opinion of the Competent Authority, Fellow is found to be negligent in her work or is guilty unbecoming conduct, her Fellowship is liable to be terminated by the Competent Authority with or without notice, as the circumstances of the case may warrant.
- Grant of leave to the Fellow will be according to the rules of the ICAR.
- If the Fellow leaves her assignment without permission of the Competent Authority, she shall not be paid any Fellowship amount due to her. She should intimate her resignation at least one month in advance to the Competent Authority to make alternative arrangement or else one month's consolidated pay would be recovered from the Fellow.
- She will not be entitled to (i) General Provident Fund (ii) ICAR Group Insurance Scheme (iii) All other benefits allowed to regular ICAR employees.

- Her appointment will be subject to the conditions that a Civil Surgeon of Government Hospital declares her medically fit for service.
- She shall submit a declaration regarding her marital status as in the form enclosed.
- A declaration to the effect that she is not drawing any other Scholarship/Associate ship/Fellowship or in paid employment is to be made by her in the proforma enclosed.
- On appointment, she will be required to take an oath of allegiance to the constitution of India or make a solemn affirmation to that effect as in the form enclosed.
- She should produce a character certificate from Head of the Institution last attended and a similar certificate from her present employer, if any, duly attested by a stipendiary I class Executive Magistrate (including a District Magistrate or a Sub-Divisional Magistrate).
- If any declaration given or information furnished by her proves to be false or if she is found to have willfully suppressed any material information, she will be liable for removal from Fellowship and such other necessary action as deemed fit will be taken.
- All patent rights, designs and invention derived from research work shall belong to the Council. The Council may at its discretion allow or direct any benefit thereof to be retain by or given to the inventor.
- She is not entitled to any traveling allowance to join at this Directorate.
- The award of this Fellowship is subject to the rules and regulations issued by the ICAR and as amended/modified from time to time.
- She has to submit an Undertaking on a non-judicial stamp paper worth Rs. 100/for which the information/matter is enclosed.

In case the assignment is acceptable to Miss R. Ashwini D/o Sri R. Sambamurthy, on the terms and conditions mentioned above, she should intimate her acceptance to the undersigned immediately and report herself for duty to the Principal Investigator of the above DBT Project at the Directorate of Poultry Research, Rajendranagar, Hyderabad –30 on or before 17.03.2020 failing which necessary action will be taken for cancellation of the above offer.
