OFFICE ORDER

In pursuance of this Office Notification of even number dated 21st February, 2022, on the recommendations of the Committee, the Director, ICAR-DPR, Hyderabad is pleased to appoint Sri AVGK. Murthy, Sr.Admin.Officer (Retired) DPR, Hyderabad as **Consultant on contract basis** initially for a period of one year, which may likely to be extended for another year subject to the following terms and conditions.

1. **The consultant shall sign an agreement of confidentiality with ICAR-DPR containing a clause on Ethics and Integrity.**
2. **Remuneration:** A fixed monthly amount of Rs.52,300-00 shall be admissible, which includes transport allowance. The amount of remuneration so fixed shall remain unchanged or the period of the contract.
3. No annual increment and Dearness Allowances shall be allowed during the term of the contract.
4. No HRA shall be admissible.
5. **Transport Allowance:** - An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed shall remain unchanged during the term of appointment. The amount of transport allowance is fixed @Rs.9,400-00 p.m. However, retired employees engaged as consultants may be allowed TA/DA on official tour, if any, as per their entitlement at the time of retirement.
6. **Leave of absence:** Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service. Accumulation of leave beyond a calendar year may not be allowed.
7. Medical fitness certificate may please be obtained from the AMA of this Institute or any other ICAR Institute, any Qualified Doctor of the CGHS recognized Hospital/Govt. Hospital.
8. At the discretion of the Director, ICAR-DPR, Hyderabad can terminate the services of the consultant at any time during the term of appointment by giving one month notice.

If the terms and conditions are acceptable to Sri AVGK. Murthy, Sr.Admin.Officer (Retired), he may submit an Agreement on non-Judicial Stamp paper as per the above conditions. He may report for duty to the Director, DPR, within 30 days from the date of issue of this Order.
