MEMORANDUM

On the recommendations of the Selection Committee, the Competent Authority of this Directorate is pleased to offer the temporary and Co-terminus post of Young Professional-II to **Dr.Kumbam Nihal Reddy S/o K.Gopal Reddy** at the consolidated payment of Rs.35,000/- (fixed) p.m. for a period upto 31st December, 2024 or till the termination of the scheme whichever is earlier under the NICRA Project entitled “Assessment of environmental impact of broiler chicken production with or without dietary interventions using life cycle of carbon foot prints” on the following terms and conditions:-

1. The Professional ship is **purely temporary and contractual engagement** for the period upto 31st December, 2024 or till the termination of the scheme whichever is earlier.
2. His services will be extended for every six months on satisfactory performance certificate furnished by P.I. of the NICRA Project during the period otherwise his services will be terminated without any further notice.
3. On appointment, he will draw the pay at the consolidated payment of Rs.35,000/- (fixed). He will not be entitled for any other allowances as admissible to the regular employees of the Council.
4. The Professional ship shall take effect from the date the Professional joins the Project.
5. No residential accommodation and transportation will be provided.
6. He will devote his whole time to the approved research programme/study under the Project and will not be allowed to accept or hold another appointment paid or otherwise and will be under the administrative control of the Principal Investigator of the NICRA Project.
7. His headquarters will be at Hyderabad for the present but he will be liable to serve in any of the ICAR Adhoc scheme.
8. He will not be permitted to resign his Young Professional-II during the period, except with the prior permission of the Competent Authority.
9. If, at any time in the opinion of the Competent Authority, the Young Professional-II is found to be negligent in his work or is guilty of unbecoming conduct, his Professional ship is liable to be terminated by the Competent Authority with or without any notice, as the circumstances of the case may warrant.
10. Grant of leave to the Professional will be according to the rules framed by the Council from time to time. He is entitled for Casual Leave and Restricted Holidays as per the Govt. of India/ICAR rules/instructions issued from time to time. He is also entitled for Paternity Leave as per rules of Govt. of India.
11. If the Professional leaves his assignment without permission of the Competent Authority, he shall not be paid any amount of pay due to him. However, minimum one-months' notice period is required for making alternate arrangements or else one month's consolidated pay would be recovered from him.

12. He will not be entitled to (i) General Provident Fund (ii) ICAR Group Insurance Scheme (iii) All other benefits allowed to regular ICAR employees.
- 13. His appointment will be subject to the conditions that a Civil Surgeon of Government Hospital declares him medically fit for service.**
14. On appointment, he will be required to take an oath of allegiance to the constitution of India or make a solemn affirmation to that effect as in the form enclosed.
15. If any declaration given or information furnished by him proves to be false or if he is found to have willfully suppressed any material information, he will be liable for removal from Fellowship and such other necessary action as deemed fit will be taken.
16. All patent rights and designs and invention derived from research work financed or aided by the Council shall belong to the Council. The Council may at its discretion allow or direct any benefit thereof to be retain by or given to the inventor.
17. He is not entitled to any traveling allowance to join at this Directorate.
18. He should submit photocopies of his Certificates duly self-attestation along with Original Certificates at the time of his joining duty at this Directorate.
- 19. He has to submit an Undertaking on a non-judicial stamp paper worth Rs. 100/- for which the matter is enclosed.**

In case the assignment is acceptable to **Dr. Kumbam Nihal Reddy S/o K. Gopal Reddy** on the terms and conditions mentioned above, he should intimate his acceptance to the undersigned immediately and report himself for duty to the Principal Investigator of the above NICRA Project at the Directorate of Poultry Research, Rajendranagar, Hyderabad -30 on or before 05.06.2023 failing which necessary action will be taken for cancellation of the above offer.
